

**About FAS Registration**

In May 2022, the FAS faculty voted to shift course enrollment to the semester before courses start, beginning with registration for Spring 2024 courses.

Registering the semester before courses start will provide Harvard College and GSAS students with an earlier period to register for courses, more flexibility to adjust class schedules, and the ability to set their class schedules ahead of time and therefore be more thoughtful in their planning. Students will have time during the first week of classes to adjust their schedules during the add/drop period.

**About this Timeline**

The accelerated registration planning timeline will have a significant impact on the Fall 2023 semester, as you will need to meet earlier deadlines for Spring 2024 courses while simultaneously meeting standard deadlines for Fall 2023 courses. While you will need to meet earlier deadlines, most of the information we will ask you to provide is what we ask for each semester.

This timeline features key academic calendar dates and planning dates and deadlines. The FAS Registrar's Office will reach out regularly with resources and reminders about upcoming action items.
